

DECLINATION OF SENIOR NONCOMMISSIONED OFFICER (SNCO) PROMOTION CONSIDERATION**PRIVACY ACT STATEMENT**

AUTHORITY: DAF is authorized to collect the information requested on this form pursuant to 10 U.S.C. 9013, Secretary of the Air Force, as implemented by Air Force Instruction 36-2608, Military Personnel Records System. DAF is authorized to collect your Social Security Number (SSN) by Executive Order 9397 (November 22, 1943), as amended by Executive Order 13478 (November 18, 2008).

PURPOSE: Information is collected to ensure accurate and positive identification of the individual for the maintenance of military personnel records. Your SSN may be used as individual identifiers for actions/processes related to promotion.

ROUTINE USES: Information provided may be disclosed to personnel management and pay administrators to document and update pay-impacting promotion adjustments for Airmen. Pursuant to 5 U.S.C. 552a(b)(3) as permitted under 5 U.S.C. 552a(b) of the Privacy Act of 1974, as amended, information may be disclosed outside the DoD as a routine use as follows: To contractors, consultants, students, and others working for the federal government when necessary; To the appropriate law enforcement authorities; To the Department of Justice for representation in litigation; In an appropriate court or administrative proceeding where the records are relevant; To the National Archives and Records Administration for records management inspections; To a Member of Congress or staff acting upon the Member's behalf; To appropriate agencies or Federal entities to manage potential breaches; To such recipients as are mandated by Federal statute or treaty.
